I serve as the Chief of Asset Management at Ohio Capital Corporation for Housing (OCCH), a not-for-profit organization involved in the creation and perseveration of affordable housing primarily in Ohio and Kentucky. Over our 25 year history, OCCH has invested in 675 housing developments representing over 33,500 units of housing. We interface with over 100+ managing agents and literally thousands of persons involved the management of affordable housing: site managers, maintenance personnel, regional managers, etc.
